

Next is the consideration for approval of three year Law and BA LL.B integrated law courses. For this two things has to be seen, one the law courses of three year LL.B. degree course and five year BA LL.B integrated law course earlier was attached to Vinoba Bhave University, Bareilly and approval of the Bar Council of India was upto the academic year 2017-2018, question is of its extension. Secondly the inspection report shows number of shortcomings.

All the faculty members appointed, are on contractual basis, which is against the statutory rules of Bar Council of India. As per the Rule, each faculty Member are to be appointed on regular basis and paid UGC scale. Since, this course is running for a long time when it was attached to Vinoba Bhave University, Bareilly, Hazaribagh, now it has become the Department of this

University established under statute, the University should answer and modify the payment in terms of the said rule to each one of them on UGC scale. Reply may be sent within six weeks for matter to be considered. No Centre of Legal Education including University can run law classes on contract basis. The University also directed to provide the statues of the law courses after Academic Session 2017-2018.
